SETTLEMENT TERMS

All account strictly 30 days. Tuff Tubbs Australia's accounting month ends on the last working day of each month, and all transactions from the previous month are payable by that time.

RETURNS

An Authorization number must be obtained from Tuff Tubbs Australia for any returns to be accepted. Freight on returns is the responsibility of the Customers unless Tuff Tubbs Australia gives written authority for the freight to be paid by Tuff Tubbs Australia.

NOTE:

It is an express condition of the supply of all products by TUFF TUBBS AUSTRALIA that property and legal title to such goods shall not pass to the customer with physical possession of the goods and that property in and title to the goods shall not pass until all sums are paid.

TUFF TUBBS AUSTRALIA reserves the right to recover possession of any goods supplied by it which have not been paid for.

Whilst Tuff Tubbs Australia has title to any Goods, it may without notice enter upon premises occupied by the Customer (or any receiver, receiver and manager, administrator, liquidator or trustee in bankruptcy of the customer) to inspect and Goods and may take possession of any Goods if any payment due from the Customer to Tuff Tubbs Australia is overdue.

If Tuff Tubbs Australia retakes possession of any Good, Tuff Tubbs Australia has the absolute right to sell or deal with those Goods in any way, and the Customer must pay Tuff Tubbs Australia the difference between the outstanding debt and the sale proceeds of those Goods. The Customer hereby irrevocably authorizes Tuff Tubbs Australia to do all things necessary to sell those goods.

The customer must pay Tuff Tubbs Australia's costs and expenses in exercising or purporting to exercise its rights as above.
